- U.S. bank or brokerage account for the past six months with a minimum balance of \$500,000
- U.S. residency

Owner of established foreign company actively engaged in business for the past 12 months and transacting business in the U.S.

Spouses of foreign nationals meeting these criteria can qualify for coverage as well without establishing their own interest.\*
